Cary Varblow of the Ridgewood Hills Homeowners Association explained the process used for contacting property owners in the affected areas, which are actually Ridgewood Hills Subdivision Nos. 1-4.

Moved by Mr. Reaume, seconded by Ms. Arnold, to approve the proposed amendment to the Ridgewood Hills Subdivision Nos. 1-4 Association Declaration of Restrictions prohibiting chain link fencing and above ground pools. Ayes all.

**3) Wayne County Hazard Mitigation Plan  
Resolution Number 11-10-11-26**

Mr. Reaume explained that Township emergency management is now provided under the Wayne County Department of Homeland Security.

Moved by Ms. Arnold, seconded by Mr. Reaume, to approve Resolution No. 11-10-25-26 to adopt the Wayne County Hazard Mitigation Plan as the official plan for the Charter Township of Plymouth. Ayes all.

**4) Fire Station Roof Replacement**

Mr. Reaume explained that three bids were received for the roof replacement.

Moved by Ms. Arnold, seconded by Mr. Kelly, to award the contract for the Fire Station #3 roof replacement to Roof One, LLC, for the base amount of \$37,200, plus any additional repairs that may be required at the bid document designated unit prices, and authorize the Supervisor and Clerk to execute the contract for same. Ayes all.

**K. SUPERVISOR AND TRUSTEE COMMENTS**

Mr. Reaume indicated that expired or unwanted pharmaceuticals could be disposed of this Saturday, October 29, at the Township police station, as well as in many other communities.

He also alerted residents to the availability on the website of the Citizen's Guide to Local Unit Finance and the Performance Dashboard.

Mr. Bridgman reminded residents of the election on Tuesday, November 8, with polls open from 7 a.m. until 8 p.m. Absentee ballots are still being issued and his office will be open on Saturday, November 5, from 8 a.m. until 2 p.m. to issue absentee ballots. To date approximately 2,800 absentee ballots have been issued with approximately 1,200 returned.
